What is a Walk KickOff?

The three main reasons to hold a Kickoff event before the Walk are:

1. To gather as many confirmed and likely potential supporters of the Walk together at one time to get them excited about the Walk and motivated to support it.
2. To provide these supporters with some basic training on how to use the materials they will receive at the Kickoff to organize a team of walkers to participate in the Walk and to raise money for the Walk.
3. To distribute the Walk materials (primarily a Walk team captain instruction folder, Walk posters and brochures) to all volunteers in an efficient, cost-effective manner.

The 2016 Walk4Hearing:

Walk4Hearing events are fundraising 5K (3.1 miles) walks held across the United States. Since its formation in 2006, Walk4Hearing has raised over \$9 million dollars for programs and services for people with hearing loss, and has grown into the largest awareness and fundraising event for the Hearing Loss Association of America® (HLAA). Collaborating with local HLAA chapters, Walk4Hearing educates the general public about hearing loss while easing the associated stigma. Striving to make hearing loss a public health issue, thousands of people of all ages, races, and backgrounds have come together to display their compassion for the cause and to make hearing loss an issue of national concern. HLAA-NJ's Looping Action Center Update

What's a loop? An induction hearing loop is single piece of wire installed inside a meeting room that, when activated, allows meeting attendees and audience members to switch on the T-coils located inside their hearing aids and/or cochlear implants. With T-coils switched on, the audio content of the content or program of the meeting or assemblage can be clearly heard and understood by those with either hearing aids or cochlear implants. If your meeting room or facility is not looped, or does not provide any method for meeting attendees to access the meeting's business or content, then they are not compliant with either Federal (Americans with Disabilities Act -- ADA) or State laws and regulations requiring accessibility, as constitutionally guaranteed to all.

HLAA-NJ has been sending letters to venues that lack any assistive listening systems, being alerted to these venues by HLAA-NJ members. The letters inform the venue of the need to provide assistive listening systems, and explaining why induction loop systems are usually the method of choice.

If you attend facilities that are lacking assistive listening systems, please send HLAA-NJ the name of the facility with the contact person, so a letter can be sent. If the venue fails to respond, then follow-up complaints may be filed. Send your information to joel.strasser@hearingloss-nj.org
